<u>Election Notification of ISAR-Delhi Chapter for the term 2023 – 2024</u>

Dear ISAR Delhi Chapter Members,

As per the Minutes of the Third Executive Committee Meeting (S.no 8) and the Third General Body Meeting (S.no. 12) held on 10th September, 2022 in Sushrut Hall and Dhanwantri Hall respectively at ESIC Medical College & Hospital, Faridabad, the following was announced regarding the ISAR-Delhi Chapter Elections: "It was announced that the elections for electing the new Executive Committee for the term 2023 – 2024 will be held in November, 2022. Prof D K Srivastava shall be the Chief Election Officer and shall oversee and conduct the entire election process."

In continuation of the process initiated, myself, Prof DK Srivastava, the Chief Election Officer, do hereby invite the nominations for election for the office bearers of the Executive Body for the term 2023 - 2024 (2 year term from 1st January, 2023 to 31st December, 2024) for the following posts:

Eligibility for Contesting and Voting in the Election

- 1. Only Life Members are eligible to contest as well as vote for electing the office bearers
- Annual Members and Student Members are NOT eligible to contest the elections and also do NOT have any voting rights

3. A Life Member may file nomination for more than one post. However, he/she is eligible only to contest for one post. Hence, the extra nominations, if filed, should be withdrawn prior to the last date for the withdrawal of nomination (11th December, 2022).

Guidelines

- 1. All nominations shall be submitted to the Chief Election Officer, Prof D K Srivastava, at the following e-mail: **elections.delhi.chapter.isar@gmail.com**
- 2. Nomination shall ONLY be accepted by e-mail when sent to the above e-mail address.
- 3. The nomination form duly filled and signed by the contestant shall be sent to the proposer and seconder for their signature. Finally, a scanned copy of the nomination form, duly signed by all, shall be sent to the election officer by email only, before the deadline (30th November, 2022). Incomplete nomination forms shall be deemed invalid and rejected.
