Dear Members of the ISAR Delhi Chapter,

As per the decisions made during the Executive Committee Meeting and the General Body Meeting of the ISAR Delhi Chapter, it has been resolved that elections for the new Executive Committee for the term 2026-2028 shall be conducted during September 2026. Prof. D. K. Srivastava has been appointed as the Chief Election Officer and shall be responsible for overseeing and conducting the entire election process.

In line with the election process, I, Prof. D. K. Srivastava, as the Chief Election Officer, hereby invite nominations for the election of Office Bearers of the Executive Committee for the term 2026-2028, covering the period from 1st November 2026 to 31st October 2028.

ELIGIBILITY FOR CONTESTING AND VOTING IN THE ELECTION

1. Only DC-Life Members shall be eligible to contest and vote in the elections for the office bearers.
2. Annual Members and Student Members shall not be eligible to contest the elections and shall not possess voting rights.
3. A DC-Life Member may file nominations for more than one post. However, he/she may contest for only one position. Any additional nominations filed must be withdrawn before the last date for withdrawal of nominations.

GUIDELINES

1. All nominations shall be submitted to the Chief Election Officer, Prof. D. K. Srivastava, through email at dharamks701@gmail.com, with copies to the President at jagritiaims2012@gmail.com and the Secretary, ISAR Delhi Chapter, at secretary.delhi.chapter.isar@gmail.com.
2. Nominations shall be accepted only through the above-mentioned email addresses.



3. The nomination form, duly filled and signed by the contestant, proposer and seconder, shall be submitted as a scanned copy through email before the prescribed deadline. Incomplete nominations shall be treated as invalid and rejected.
4. The ballot paper shall display the names of all valid contestants post-wise and column-wise.
5. Ballot papers shall be circulated electronically to all eligible voters within the stipulated timeline before voting.
6. Counting of votes shall be carried out by the Secretary and counter-checked by the Chief Election Officer prior to declaration of results.
7. Voters shall not disclose their identity (Name/LM Number) on the ballot paper.

The Secretary shall scrutinize all nominations received and, under the direction of the Chief Election Officer, display invalid nominations, if any. Following the withdrawal period, the final list of valid contestants shall be published as per the election schedule.

The election process shall be conducted in a fair, transparent and democratic manner in accordance with the Constitution and Bye-Laws of the ISAR Delhi Chapter.
